Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The goal and purpose for the PBV is to develop the Authority's property located at 1401 3rd Street and complete the Development Plan (24 additional units needed) at the Authority's Stonebrooke Development to provide affordable housing to the Elderly, Handicapped/Disabled individuals and/or VASH vouchers for Veterans and to relocate the Authority's Central Office Cost Center, the Community Building (to include a Storm Shelter) and Central Maintenance Building to the 1401 3rd Street location. Therefore, the Authority does not plan to sell, lose or use the property for any other purpose than stated above. The Authority is aware of the guidelines outlined in (HOTMA final rules and implementation.) The PHA is in the process of completing Phase I of the Lead Based Paint abatement process and is preparing to start Phase II using the \$5,000,000.00 received in CFP Grant -2022 award AL09L152501-22, as we treat the entire Valley Hill and West Circle developments for Lead Based Paint, upon notification of the presence of lead in the units that were tested. In addition, the Authority received \$2,074,999.00 in Housing Related Hazard (asbestos) grant funds AL09H152501-22 and are now preparing to start and complete replacing floor tile and remodeling the units testing positive for asbestos.</p>					

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>The Primary Mission of the Housing Authority of the City of Northport is to promote adequate and affordable Housing, Economic opportunities and a suitable living environment free from discrimination as we serve the needs of low, very low and extremely low income families in our Jurisdiction. Progress in meeting our goals are demonstrated by maintaining an annual 96-98 % occupancy rate in the Public Housing and Section Eight Programs. As per 24 CFR 903.7 the Authority will continue to contract with the Auditing Firm, Lawrence, Hitt and Pugh, LLC to test our waiting list for assurance that it is not implicated in a discriminatory manner and that no patterns or practice of discrimination exist along with indicators 2-7 of the SEMAP report. The Authority will continue to recognize the new definition of “Extremely Low Income, ELT” as those whose income does not exceed the higher of 30% of the Area Media Income or the Federal Poverty Level. The Authority will continue the changes in the Section Eight Program as describe in Circular Letter No. BIR-PHD to include biennially inspections and utility allowances for a family to be the lower allowance amount for the unit size or the utility allowance amount for the unit size rented by the family. The Authority is maintaining its commitment to PIH Notice 2008-41 Section 7 (to continue to serve the needs of children and adult victims of domestic violence, dating violence, sexual assault or stalking) in a manner of providing contact information, transportation etc, to the local Agency, Turning Point (where one of the Authority’s Employees serve on the Board of Directors.) In addition, the Authority’s goal is to provide housing preference to the above listed individual (including family members listed on the lease) as well as refrain from evicting or terminating the assistance of the families. The Authority will continue to collaborate its annual (Pre-COVID) events such as HUD Strong Families, Christmas Celebrations, (to include a personal designed Angel Tree in Memory of the Authority’s former Section Eight Housing Choice Voucher Manager, Christmas 2024) assisting NHA resident’s with field trips, etc. The Authority will continue to enforce its “Smoke Free Policy” and maintain the “smoke free signs throughout the developments. The Authority received permission from the U. S. Department of Housing and Urban Development to rename the Family Life Center and the Base Ball field located in the Valley Hill Development in memory of it’s former Executive Director Milo “DOC” Pearson, currently we are preparing the dedication ceremony. The Authority will continue its effort and remain committed to the “Memorandum of Understanding” for the Tenant Protection Vouchers for the Foster Youth Initiative Program. The Authority’s first FYI voucher holder located decent, safe and sanitary housing and officially moved into the unit 08/01/2023. The Authority’s CEO/Executive Director is currently exploring ideas (needs assessment) regarding housing type, bedroom size and numbers needed prior to seeking/resenting a development plan for the property located at 1401 3rd Street. The Authority has completed the installation of its carbon monoxide smoke detectors in all units serviced by fuel burning devices and is currently in the monitoring and testing phases. The Authority is continuing the process of testing and abating mold fungal remediation and restoration, using funds from line item 1480 of its rolling CFP grants. The NHA will continue to collaborate with Kevin Shobe, CEO/President of “Your Real Next Step.” The organization was designed to offer numerous of activities and skills to enhance the lives of the youth and adults in our area to deter gang/ gun violence and others. Since our initial collaboration, the organization has held numerous of activities with our residents to include a Summer Camp (awesome) clothes/shoes (shopping spere) which were donated by Donors of the Shobe organization. In addition, the NHA will collaborate program activities with the “Get Fit in the Spirit, LLC, Project Connect, Inc. 501c3 and CMW Productions (AKA THE DOMINO EFFECT.) The organization is designed to strengthen the bonds within the families promoting spiritual, mental , physical and emotional growth of all family members. The NHA completed Phase I of the new parking area located at 3500 West Circle and 5th Street. The Authority’s Engineering Team has completed the initial design of Phase II of the Parking Improvements project (to ensure the safety of the residents living at 3500 West Circle and 30th Avenue. The Authority will continue its modernization program to further ADA compliance and others. The Authority received \$2,074,999.00 in CFP grant AL09H152501-22 for Housing Related Hazards (asbestos) Risk Assessment, Hazard Controls, Clearance Examinations and Relocation cost and \$5,000,000.00 in CFP grant AL09L152501-22 for Lead Based Paint Risk Assessment, Hazard Controls, Clearance Examinations and Relocation cost/modernization, etc. The Board of Commissioners of the Housing Authority of the City of Northport in its February 06, 2024, regular scheduled Board meeting designated its CEO/Executive Director to host the meeting to discuss the Annual Plan, its attachments and the CFP grant awards with the Public. The public meeting as held on March 01, 2024, via virtual communication and an in person meeting was held with the Resident Advisory Board on March 20, 2024, 12 noon on location of the Authority, 3500 West Circle, #38, Northport, AL 35476. The Authority is in receipt of the comments received from the Resident Advisory Board and “Your Real Next Step” CEO/President Kevin Shobe and we fully concur with the ideas and suggestions and plan to support them as well as provide guidance to ensure that the program activities are implemented in a manner that would achieve the highest and best results.</p>
